## FIRST AMENDMENT TO BYLAWS OF THE ASSOCIATION OF UNIT OWNERS OF NORTH SHORE TERRACE CONDOMINIUM

## Recitals

- A. North Shore Terrace is a condominium in Newport, Lincoln County, Oregon, consisting of six stages, the first of which was created by declaration recorded on April 1, 1992, in Book 242, page 0518, Records of Lincoln County, Oregon.
- B. The bylaws of the Association of Unit Owners of North Shore Terrace Condominium were recorded on April 1, 1992, in Book 242, page 0531.
- C. The unit owners wish to amend the bylaws to make the Association responsible for the maintenance and repair of the decks, which are limited common elements.

NOW, THEREFORE, the bylaws of the Association of Unit Owners of North Shore Terrace Condominium are amended as follows:

- 1. The last sentence of Article X, paragraph 2, is hereby amended to read as follows:
- "Additionally, each unit owner shall be responsible for maintaining the limited common elements in good repair and condition, except for decks, which shall be maintained and repaired by the Association."
- The first sentence of Article X, paragraph 6, is hereby amended to read as follows:

"Nothing herein shall be so construed so as to prevent the Association from retaining the services of personnel necessary for the maintenance, upkeep and repair of the common elements, and the expense of same shall be the expense of the Association, except as otherwise provided in Article X, paragraph 2, above."
