*Mr. Moore advised he was turning over all account books, blue prints and all other material pertinent to the development.

*Mr. Mishey advised his daughter has been handling the money matters of the association and would continue to be available for the in-coming treasurer for 3 hours, which has already been paid for by A & D Development. He further advised he was uncertain if the bookkeeper would be willing to stay on if the association wished to retain her services.

Ballots distributed to owners and absent owners were marked off the ballots.

Reuben Johnsen motioned that a brief narrative be given by each owner interested in participating as a director. Motion seconded and passed. Each owner gave a brief resume of experience and personal interest in participating.

The four officers will be authorized to sign checks and all checks will require two signatures.

SECRETARY: Dennis Dotson will make a complete roster of owners, their unit numbers and telephone numbers, which shall be distributed to each owner. Additionally, he will check into getting a Tax ID number for the Association, including 501 3-C non-profit status. Both will be necessary for tax purposes as our bank accounts increase and we need to consider filing tax return information.

VICE CHAIRMAN: Bill Mishey will contact Mark Colson at Doerfler Insurance about indemnity insurance for the board and obtain an estimated cost.

CHAIRMAN: Don Gestson called for another meeting of the directors for Friday, January 9, 1998 at 7:30 p.m. at the home of Virginia Reynolds, Unit 96F. The directors were asked to read the by-laws each received when they closed escrow. Information gathered by the officers will be presented at that time.
